#### **PUBLIC COMMENT: None**

MINUTES: Submitted by Josuweit.

\*\*Motion by Wilkes, seconded by Moyer to approve the January 11, 2018 meeting minutes as submitted. The motion carried unanimously.

#### FINANCIAL REPORTS: Submitted by Josuweit.

Ference referenced the Financial reports provided in the packet noting the Budget vs Actual report will be provided in the March packet. The Board was provided with a Profit & Loss statement for January.

\*\*Chairman Ference ordered the Financial Reports to be filed for audit.

Longmore joined the meeting by phone at 6:07.

# **ACTION ITEMS:**

# **Interim District Leadership**

Ference informed the Board of an Executive Session that will be held at the end of the meeting to further discuss this item.

#### **RECLAIM Resolution**

Ference referenced the RECLAIM Resolution included in the Board packet (item 4b). The District has been asked to support the revitalization of the coal communities by sending letters of support for H.R. 1731 to local legislators. Components to the resolution are reclamation and restoration of abandoned coal mines. Pennsylvania would receive \$253 million over the next 5 years for these projects. Ference asked the Board if they had any questions regarding the resolution.

\*\*Motion by Wilkes, seconded by Hanish to adopt the resolution and to send letters of support to the local federal legislators. The motion carried unanimously.

#### **Additional Items:**

Ference informed the Board that Harvey's Lake Borough submitted an Erosion & Sediment Control Memorandum of Understanding (MOU) between District and the Borough.

\*\*Motion by Hanish, seconded by Moyer to approve the MOU with Harvey's Lake Borough. The motion carried unanimously.

Levitsky noted that he will be working with Wyoming Valley Sanitary Authority on MS4 permit compliance and will discuss working on a master MOU document to include the 31 municipalities.

Ference noted he received an email from PACD executive Director Brenda Shambaugh regarding Governor's Budget proposal. He explained to the Board that the District receives funding from the Dept. of Agriculture and DEP. PACD noted the proposed funding for DEP and PDA is the same as last year. PDA funding was \$869,000 and DEP funding was \$2.5 million. Ference did note that the budget is not final, and the Environmental Stewardship Fund has not been addressed yet, since its funding comes from various sources.

Levitsky referenced the district's existing Growing Greener Grant for The Lands at Hillside Farms (The Lands) project. Levitsky explained the project is for dam removal, he has received two quotes; CEC quote for \$66,000.00 and Barry Isett quote for \$17,250.00. Levitsky is waiting on additional services to be added to the quote and plans on presenting a proposed contract to the March Board meeting. Longmore explained that the dam removal is part of an overall multi-conservation practice project that will be done in partnership with The Lands. The agricultural BMP's will include a new dairy barn and manure storage/management structures. The ag engineer is being paid for by The Lands, who contracted with Barry Isett & Associates to handle some of the permitting work for the ag portion of the project. Barry Isett is already part of the overall scope of work so that is why Levitsky reached out to the firm for a quote for the dam removal portion. Levitsky explained the project must be completed by October, or it will have to wait until January due to wild trout water permit restrictions. Discussion was held on the permitting and time frame of the project. Ference asked if the Board was satisfied with the quote from Barry Isett, and if Levitsky should continue with the contracting process with them. There was consensus to move forward and address the contract at the March board meeting.

Ference noted staff reports are included in the packets.

PA DEP – Kleiner provided a verbal and written report. Kleiner will provide orientation for Matt Vough and Chris Maylath at 5:00 prior to March 8<sup>th</sup> Board Meeting.

PACD – Ference along with Hanish attended the PACD/SCC Winter meeting. The PACD Executive Council voted on the following items listed below:

Hanish reported on the Spotted Lanternfly presentation. The Spotted Lanternfly was first discovered in Berks County in 2014 and has since spread to other southeastern counties. Neighboring States are considering quarantining fruits and hardwoods from Pennsylvania.

Ference explained the financial issues noted through district audits on the segregation of duties. The audits showed 34 Districts with no issues, and 21 Districts show "lack of segregation of duties". SCC is looking for solutions to the issue. Proper recording of Accounts Payable was also discussed.

Ference highlighted the report from the Luzerne Farm Services Agency (FSA). There is a copy in the office if Board Members would like to read the article. Ference noted Lenny Burger, III (son of Lenny Burger, Jr.) was elected for a 3-year term on the Luzerne FSA County Committee.
