BOARD REORGANIZATION:

Wilkes turned the meeting over to Skibiel to act as Chair Pro Tem to conduct the election of officers.

Skibiel asked if there were any other nominations. Receiving none, she entertained a motion to close the nominations for Vice Chair and to elect Hanish to the position.

**Motion by Moyer, seconded by Wilkes to close the nominations and to elect Hanish as Vice Chair. The motion carried unanimously.

Skibiel opened the floor for nominations for Secretary/Treasurer of Luzerne Conservation District Board.

**Motion by Hanish, seconded by Herbert to nominate Tracey Chonko as Secretary/Treasurer.

Skibiel asked if there were any other nominations. Receiving none, she entertained a motion to close nominations for Secretary/Treasurer and to elect Chonko to the position.

**Motion by Wolovich, seconded by Wilkes to close the nominations and to elect Chonko as Secretary/Treasurer. The motion carried unanimously.

Skibiel turned the meeting over the Chairman Wilkes.

Wilkes noted the draft list of 2023 Committee and Advisory/Work Group Appointments included in the board packets. He asked if any changes were desired for 2023. Skibiel offered to serve on a committee. Longmore suggested the Ag Program Advisory Group, and Skibiel agreed to serve.

**Motion by Hanish, seconded by Herbert to approve the December 19, 2022 meeting minutes as submitted. The motion carried unanimously.

FINANCIAL REPORTS:

Wilkes noted the financial reports in the board packet and invited questions.

**Wilkes ordered the Financial Reports to be filed for audit.

COOPERATING AGENCY REPORTS:

NRCS – Kearse provided a written and verbal report.

DEP – Skibiel provided a written and verbal report. Skibiel noted an Employment Law Seminar will be held in Jim Thorpe on February 23rd. Longmore, Herbert, and Hanish will attend.

PACD – A written report was included in the board packet. Longmore noted the PACD Executive Council video conference will be held on January 26th at 10:00 AM. Herbert reported on the PACD Legislative Committee meeting.

STAFF REPORTS:

Wilkes noted that staff reports were included in the board packet as item 5.

BUSINESS ITEMS:

Sale of 2018 Nissan Frontier

Wilkes stated he would be abstaining from any votes on this agenda item. Longmore noted that he previously received quotes of about \$19,000 for the trade-in of the 2018 Nissan Frontier. Jackson Township inquired about purchasing the vehicle for \$19,000.

**Motion by Wolovich, seconded by Hanish to approve the sale of the 2018 Nissan Frontier to Jackson Township for \$19,000.00, as-is. The motion carried. Wilkes abstained from the vote.

2023 Countywide Action Plan Grant Additional Funds Request

Longmore announced that DEP awarded the district an additional \$45,557 in the CAP Implementation Projects grant for 2023. This is an amendment to the grant agreement that was approved last year.

**Motion by Herbert, seconded by Hanish to approve the additional funding of \$45,557 for the Countywide Action Plan Implementation Projects grant. The motion carried unanimously.

Agricultural Conservation Assistance Program Delegation Agreement

The SCC provided the delegation agreement for the new Agricultural Conservation Assistance Program for the board's consideration.

**Motion by Burger, seconded by Moyer to approve the Agricultural Conservation Assistance Program Delegation Agreement with the State Conservation Commission. The motion carried unanimously.

Dirt, Gravel, & Low-Volume Road Program Delegation Agreement Renewal

Longmore noted that the board packets included a draft version of the delegation agreement with the SCC that would extend the district's involvement in the program for another five years. The SCC made only a few minor changes to the agreement. Once the SCC approves the final document, it will be presented for the board to take formal action.

Employee Step Increase Acknowledgement

Wilkes acknowledged that Schlauch successfully achieved a step increase within the district's Employee Pay Schedule.
